The report tonight reauthorizes the previous Council approval, but for any and all corporations included is said settlement through the Attorney General, including but not limited to those arising from *In Re: National Prescription Opiate Litigation – Case No. 1:17-md-2804 (United States District Court Northern District Of Ohio Eastern Division).*
