#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, ESTABLISHING THE HOMELESS AD HOC SUBCOMMITTEE PURSUANT TO LEGISLATIVE POLICY 1.07 COUNCIL SUBCOMMITTEE MEETINGS OF THE CITY COUNCIL

WHEREAS, on March 19, 2024, the City Council provided direction to develop a Homeless Ad Hoc Subcommittee pursuant to Legislative Policy 1.074 Council Subcommittee Meetings; and

WHEREAS, the Assistant City Manager along with the Mayor and Mayor Pro Tem worked to develop the scope and characteristics of said Homeless Ad Hoc Subcommittee, which are detailed below.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, DOES HEREBY RESOLVE THAT THE HOMELESS AD HOC SUBCOMMITTEE IS ESTABLISHED WITH THE FOLLOWING SCOPE AND CHARACTERISTICS:

#### Section 1. Specific Objectives & Task (Policy Focused)

Specific tasks and objectives of the Ad Hoc Subcommittee shall include, and be limited to, the following:

- Focus on solutions addressed by residents, which may include the examples below:
  - Encampments within the city jurisdiction
    - Develop a revamped coordinated effort of response
      - Clearly identified/codified process
      - Identify a standard response time for each call
        - How many individuals are accepting services
        - Identify the individuals who are not accepting services
        - Clearly identify that contact is being made because reports are that individuals are seen back in the same area hours after our initial response

- Look at trend data of engagement for hot spots and future engagement of those areas
- Trespassing Law California Penal Code 602 What is the city's efforts in informing businesses and private property owners of their right to invoke such law
  - Notice to Vacate 72 hours
- CalTrans jurisdiction Staff continue to work with District 8 on a weekly basis
  - CalTrans process and policies related to encampments
  - CalTrans response times
    - Notice to Vacate 72 hours
    - Reporting on the initial call to see what programs, services, etc were provided. Update on where the individuals are after initial contact
- Shopping centers or other private property
  - Private Security requirement for new development
  - Code Violations Muni Code must still be adhered to. What is Community Enhancements process. Educate the business community about our processes
    - Revision to our Ordinance to require all shopping centers to have private security
  - Trespassing Law California Penal Code 602 What is the city's efforts in informing businesses and private property owners of their right to invoke such law
    - Notice to Vacate 72 hours
- A forum/space so residents can attend and share their concerns
- All action items approved by Subcommittee need to be brought to council for consideration
- Create additional partnering opportunities with Community Based Organizations (CBO) & Non-Profits (NP)

- Developing additional programs based on needs/feedback
- Provide updated metrics related to the City's efforts and programs
  - Knowing existing beds that are available for Moreno Valley programs to use
  - Knowing metrics from these shelters as well (i.e. % used)
- Eviction Assistance
  - Create program(s) to reduce the number of evictions in the city to avoid the possibility of individuals being homeless (i.e. MoVal Rental Assistance Program \$20M+)
  - Ordinance revisions (property rights concerns)
