L.1 REGIONAL COMMISSION/COMMITTEE/BOARD

L.1.1 March Joint Powers Commission (JPC)

Councilmember Delgado reported the following:

 We heard an update on the Base's 452nd Air Mobility Wing and another on the Air and Marine Operations Center.

- We heard a report on the Sheriff's Truck Enforcement patrols on Van Buren.
- We received the annual report on the Foreign Trade Zone, and
- We approved moving the dates and location for the JPA
 Commission meetings to accommodate requests for
 livestreaming. Starting on October 2nd, the regular
 Commission meetings will occur on the first Wednesday of
 the month at 3 pm in the Board Chambers at the Riverside
 County Administrative Center.

L.1.2 Riverside County Habitat Conservation Agency Board of Directors (RCHCA)

Mayor Pro Tem Barnard reported the following:

At the RCHCA Board of Directors meeting on September 12, 2024, the activity reports for Agency Attendance Roster, Stephens' Kangaroo Rat (SKR) Fee Collections and Reserve Management and Monitoring Efforts, Contracts and Grants, Single Signature Authority, Reserve Management for the Southwestern Riverside County Multi-Species/Lake Mattews Reserves, and Fiscal Year 2023/2024 Annual Review/Financial Analysis were received and filed.

Additionally, staff recommendations were approved for the following:

- Authorization for professional services for an SKR fee audit
- 4th Quarter Budget Amendment mainly due to increased revenue
- Amendment to the RCHCA Conflict of Interest Code
- Endowment Funds Requests for Sycamore Canyon for habitat management equipment

Additionally, the Board was presented with an update on the Stephens' Kangaroo Rat (SKR) Habitat Conservation Plan (HCP), which is set to expire in 2026. The Board voted to authorize RCHCA staff to coordinate with appropriate agencies to update the SKR Habitat Conservation Plan and renew the necessary permits.

The Board also authorized staff to solicit proposals for a Nexus Fee Study and develop a comprehensive update to the Stephens' Kangaroo Rat Mitigation Fee (SKRMF) schedule. This study will assess the adequacy of the current SKR mitigation fee and recommend any necessary adjustments.

L.1.3 Riverside County Transportation Commission (RCTC)

Councilmember Delgado reported the following:

The Commission approved an agreement with California Department of Transportation (Caltrans) for quality management services in support of a Project Study Report-Project Development Support (PSR-PDS) for the North Main Corona Transit Connector Project.

The Commission awarded an agreement to Transmax for Software as a Service (SaaS) for the Interstate 15 SMART Freeway Pilot Project for a two-year term, in the amount not to exceed of \$3,477,497.

L.1.4 Riverside Transit Agency Board of Directors (RTA)

Mayor Pro Tem Barnard reported the following:

The Committee authorized the award of an agreement to Forbes Construction for the purchase and installation of fourteen (14) air conditioning units.

Last year, RTA was awarded the Regional Early Action Planning Grant (REAP) 2.0 Funds in the amount of \$2,378,635. As such, the Committee approved the use of the REAP 2.0 funds toward the GoMicro Microtransit Pilot Program Extension.

L.1.5 Western Riverside Council of Governments Executive Committee (WRCOG)

Councilmember Baca-Santa Cruz reported the following:

At the WRCOG Executive Committee meeting on September 9, 2024, reports for Fiscal Department Activities, Committees and Agency Activities, Various (external) Committees, I-REN Monthly Activities, and 2024 General Assembly were received and filed.

Additionally, staff recommendations were approved for the following:

- Fiscal Year 2024/2025 budget amendment relating to the HERO Program
- TUMF Programs agreements for credits and reimbursements
- 2024 TUMF Southwest 5-Year Transportation Improvement Programs (Canyon Lake, Lake Elsinore, Murrieta, Temecula, Wildomar, and the County of Riverside)
- Deferral of foreclosures related to PACE
- Amendment to the WRCOG Conflict of Interest Code
- Selection of Admiral William H. McRaven, a retired U.S. Navy, Four-Star admiral, best-selling author, and former Chancellor of the University of Texas System as the 2025 General Assembly speaker
- Increase maximum bond authorization for the C-PACE Program
- Policy for adding agencies to the WRCOG structure

The Executive Committee also approved the TUMF Nexus Study and updated Fee Schedule. All WRCOG member agencies must adopt an updated TUMF Ordinance before the new fee becomes effective in their respective jurisdiction. The fee is targeted to become effective April 1, 2025.

L.1.6 Western Riverside County Regional Conservation Authority Board of Directors (RCA)

Mayor Cabrera reported the following:

At the RCA Board of Directors meeting on September 9, 2024, the activity reports for MSHCP Fee Collections, Joint Project Review (JPR) status, Property Acquisition, Agency investment, Consultants, and Quarterly Public Engagement Metrics, and Single Signature Authority were received and filed.

Additionally, the Board received a State and Federal Legislative Update. The updates included a recommendation that the Board of Directors support Proposition 4 (the Parks, Environment, Energy, and Water Bond Measure), placed on the November General Election ballot through the passage of Senate Bill 867 (Senator Ben

Allen, El Segundo), which will provide \$10 billion in state bonds for various projects and programs if enacted, including \$870 million for land acquisition to support habitat conservation. The Board voted to stay neutral as it relates to Proposition 4.

Lastly, the Board voted to authorization acquisition of tax-defaulted properties from the Riverside County Treasurer-Tax Collector for open space for wildlife and plant life conservation.
