## Recommendation(s)

That the City Council:

1. Direct the City Clerk to cancel the November 5, 2024, Regular Meeting of the City Council and Meetings of the Ancillary Governing Bodies of the City: or

2. Provide alternate direction to the City Clerk not to cancel the November 5, 2024 Regular Meeting.

### **SUMMARY**

This report provides an opportunity for the City Council to determine whether or not the Regular Meeting of the City Council and the Ancillary Governing Bodies of the City will be cancelled due to the meeting date falling on the day of the City's General Municipal Election of November 5, 2024.

#### DISCUSSION

The City's General Municipal Election will be on November 5, 2024 for the purpose of electing the Mayor and Councilmembers to District 1 and District 3.

In addition, Measure "U", Moreno Valley Essential Services Reauthorization of the proposed one-cent (1¢) Transaction and Use Tax ordinance, is on the same ballot.

Over the past ten years, the City Council has cancelled the Council meeting when it is fallen on Election Day, as evidenced by the chart below.

While some surrounding cities cancel their regular meetings held on the same day as the election, others do not.

- 1. Authorize the City Clerk to publish the notice of cancelation of the November 5, 2024 Regular meetings of the governing bodies of the City.
- 2. Provide an alternate direction or no direction, resulting in the City Clerk noticing the Regular meeting on November 5, 2024.
