RESCHEDULING THE STARTING TIME OF THE REGULAR CITY COUNCIL MEETINGS, REGULAR CLOSED SESSIONS AND SPECIAL PRESENTATIONS

(REPORT OF: CITY ATTORNEY)

TITLE SUMMARY: Discussion Regarding Possibly Rescheduling the Starting

Time of The Regular City Council Meetings, Regular Closed

Sessions and Special Presentations

Recommendation(s)

That the City Council:

1. Provide direction to the City Attorney regarding whether to produce a Resolution that changes the scheduling of the City Council Regular Meetings, Regular Closed Sessions and/or Special Presentations.

SUMMARY

At the September 17, 2024, Regular Meeting of the City Council, staff was directed to bring back as a future agenda item for the City Council's consideration, a proposed change in the scheduling of the starting times of the City Council Regular Meetings and Closed Sessions and/or Special Presentations, that routinely take place on the same days of Regular Meetings of the City Council.

DISCUSSION

Regular Meeting Schedule

The Brown Act provides that a legislative body (i.e., City Council) must take formal action to establish a time and place for holding its "Regular Meetings." This simply means that Regular Meetings of the City Council must be set by Ordinance or Resolution. Pursuant to sections 2.04.010 (Time of City Council Meetings) and 2.04.020 (Place of City Council Meetings) of the Moreno Valley Municipal Code, as set forth below, the time and place Regular Meetings of the City Council must be set by Resolution.

Moreno Valley Municipal Code Section 2.04.010 Time of city council meetings.

Commencing with the first regular meeting or study session after the effective date of this chapter, whichever first occurs, the meeting schedule of the city council <u>shall be</u> as set by resolution of the council.

Moreno Valley Municipal Code Section 2.04.020 Place of city council meetings.

Locations of the meetings of the city council shall be as set by resolution of the council.

In light of the above, Regular Meetings of the City Council have been established by Resolution and placed and referenced in the City's <u>Rules of Procedure for Council Meetings and Related Functions and Activities</u> ("Rules of Procedure"), as set forth below. As you can see, Regular Meetings of the City Council are currently scheduled for the 1st and 3rd Tuesdays of each month, commencing at 6:00 p.m.

1. MEETINGS 1.1. REGULAR MEETINGS 1.1.1. TIME AND PLACE. 1.1.1.1. REGULAR TIME AND PLACE.

Regular meetings of the City Council shall be held on the <u>first and third Tuesdays of each month at 6:00 p.m</u>. in the City Council Chambers of City Hall or such other time and place as shall be specified by resolution of the City Council.

As such, to change the scheduling of Regular Meetings of the City Council, the City Council must adopt a Resolution making any necessary changes to the Rules of Procedure. It should be noted that when the City Council goes "dark" in July, it must "cancel" the July City Council Regular Meetings in advance so that the City Clerk can prepare, post, and publish a Notice of Cancellation in the same manner as Regular Meeting agendas. However, the City Council may formalize (via a Resolution) its Regular Meeting schedule to exclude Regular Meetings for the month of July; this would not prelude the City Council from holding Special Meetings instead during July.

Closed Session Schedule

Although the City Council Regular Meetings are set to commence at 6:00 p.m., the Rules of Procedure provide that Regular Closed Sessions shall commence at 4:30 p.m. on the same day of City Council Regular Meetings, as set forth below.

- 1. MEETINGS
 - 1.7. CLOSED SESSIONS.
 - 1.7.1. REGULAR CLOSED SESSIONS.

Regular closed sessions shall be held at 4:30 p.m. in advance of Regular City Council Meetings and Study Sessions, unless no closed session items are scheduled for that meeting.

Just like changing the scheduling of Regular Meetings of the City council, to change the scheduling of Regular Closed Sessions of the City Council, the City Council must adopt a Resolution making any necessary changes to the Rules of Procedure.

Special Presentations Schedule

The Rules of Procedure further set Special Presentations to commence at 5:30 p.m., as set forth below, during Regular Meetings of the City Council, which again commence at 6:00 p.m.

- 1. MEETINGS
 - 1.2. SPECIAL PRESENTATIONS.

In order to promote efficiency in handling the business of the City and to provide for proper recognition of those making a contribution to the community, the City Council shall, from time to time, absent special circumstances such as scheduling issues precluding a recipient from attending at that time, convene at 5:30 p.m. prior to a regular City Council Meeting for ceremonial purposes. Such a session shall be posted on the agenda for the regular Council Meeting as "Special Presentations". Agenda items for a Special Presentations session shall include only ceremonial matters, including but not limited to, giving or receiving of gifts and awards, proclamations or previously adopted resolutions.

Again, just like changing the scheduling of Regular Meetings and Regular Closed Sessions of the City council, to change the scheduling of Special Presentations, the City Council must adopt a Resolution making any necessary changes to the Rules of Procedure.

Proposed Resolution

If the City Council decides to change the scheduling of its Regular Meetings, Regular Closed Sessions and/or Special Presentations, the City Attorney will prepare the requisite Resolution to implement any such changes, which can be presented at a subsequent City Council meeting as a Consent Item, unless pulled for further discussion and deliberation at that

subsequent meeting. In addition to making specific changes in the scheduling of any of the above, the Resolution will also include amendments to any other provisions of the Rules of Procedure that reference the respective schedules, such as those set forth in section 1.1.2.1 (Order of Business) of the Rules of Procedure which references the time that Closed Session, Special Presentations and Call to Order of the Regular Meeting should commence.

ALTERNATIVES

- 1. Do not make any changes to the scheduling of City Council Regular Meetings, Regular Closed Sessions, and/or Special Presentations. (Staff has no preference.)
- 2. Make changes to the scheduling of City Council Regular Meetings, Regular Closed Sessions and/or Special Presentations, and direct the City Attorney to prepare the requisite Resolution for consideration at a subsequent City Council meeting as a Consent item, unless pulled at the time for further discussion or deliberation at the respective subsequent City Council meeting. (Staff has no preference.)

FISCAL IMPACT

Any changes to the scheduling of City Council Regular Meetings, Regular Closed Sessions and/or Special Presentations should not have any fiscal impact since any changes to the scheduling of City Council Regular Meetings, Regular Closed Sessions or Special Presentations will not require any additional time or resources to simply change the time of such meetings.

NOTIFICATION

Public notice of this item has been provided at least 72 hours in advance of the October 15, 2024, City Council Regular Meeting pursuant to the Brown Act, and no changes will be officially made until after the item appears again in the context of a Resolution that will be placed on a future Consent Calendar which will be noticed within 72 hours of the respective subsequent City Council meeting.
