TITLE SUMMARY: Authorization to Award a Design Contract to Dewberry

Engineers Inc. for the Steeplechase Drive Reconstruction Project Number 801 0107 Located on Steeplechase Drive

Between Ironwood Avenue and Kalmia Avenue

Recommendation(s)

That the City Council:

- 1. Award a design contract to Dewberry Engineers Inc. for the Steeplechase Drive Reconstruction Project Number 801 0107 Located on Steeplechase Drive between Ironwood Avenue and Kalmia Avenue; and
- 2. Authorize the City Manager to execute a contract with Dewberry Engineering Inc., in the amount of \$388,650 funded by the Measure A Fund (Fund 2001); and
- 3. Authorize the issuance of a Purchase Order to Dewberry Engineers Inc. for the amount of \$388,650 once the contract has been signed by all parties; and
- 4. Authorize the Public Works Director/City Engineer to execute any subsequent related amendments to the contract with Dewberry Engineering Inc., up to the budget as previously approved by the Council, subject to the approval of the City Attorney.

SUMMARY

This report recommends approval of a contract with Dewberry Engineers Inc. for the design of the Steeplechase Drive Reconstruction Project, Number 801 0107 located on

Steeplechase Drive between Ironwood Avenue and Kalmia Avenue. This project aims to reconstruct the pavement and median on Steeplechase Drive between Ironwood Avenue and Kalmia Avenue and will improve and widen the north side of Ironwood Avenue between Vista de Cerros Drive and Lasselle Street. Improvements to Ironwood Avenue will include sidewalk, curb and gutter, and other associated street improvements. This project is included in the adopted Fiscal Year 2023/24 and 2024/25 Capital Improvement Plan (CIP) and there is no impact to the General Fund.

DISCUSSION

Steeplechase Drive is an established community located in the northeasterly part of the City between Ironwood Avenue and Kalmia Drive. The street features an existing median lined with very mature trees. Unfortunately, the shallow root system of these trees has outgrown the existing median, causing damage to the asphalt and an uneven roadway surface, affecting drivability. To properly rehabilitate the roadway asphalt, this project will involve the removal of the existing trees and roots and will construct new asphalt, along with new concrete curbs, gutter, and a new median with updated landscaping that will beautify and enhance the new median.

The Steeplechase Drive Project will also include the widening of Ironwood Avenue between Vista de Cerros Drive and Lasselle Street. This portion of the project will involve the construction of new roadway pavement, curb and gutter, sidewalk, pedestrian and bicyclist connection, and other related street improvements. The improvements to Steeplechase Drive and Ironwood Avenue will provide a smooth and safety-enhanced roadway surface that will enhance connection and access for the residential homes in this community to schools, churches, shopping, and more.

A Request for Proposals (RFP) for Professional Consultant Services was advertised in accordance with the City's procurement processes on October 10, 2024. The City received ten (10) proposals in response to the RFP. Following a competitive selection project. The selection process was pursuant to the City's Municipal Code requirements for professional services procurement. Dewberry Engineers Inc. listed references were contacted and they provided positive feedback regarding Dewberry Engineers Inc. past services on similar projects. Staff recommends awarding a contract to Dewberry Engineers Inc. to perform the requested professional consultant services for the Steeplechase Drive Reconstruction / Ironwood Avenue to Kalmia Avenue project.

ALTERNATIVES

- 1. Approve and authorize the recommended actions as presented in this staff report. This alternative will provide the design of the Steeplechase Drive Reconstruction project and will provide necessary roadway safety and connectivity improvements for the community. Staff recommends this alternative.
- 2. Do not approve and authorize the recommended actions as presented in this staff report. This alternative will result in delaying the timely design and construction of the project. Steeplechase Drive will continue to experience an uneven roadway surface. Staff does not recommend this alternative.

FISCAL IMPACT

This project is included in the adopted Fiscal Year 2023/24 and 2024/25 Capital Improvement Plan (CIP). The available budget (Fund 2001) for Project 801 0107 is utilized to fund the costs for project design. There is no impact to the General Fund.
