Recommendation(s)

That the City Council:

1. Consider Approval of Resolution No. 2025-_____, a Resolution of the City Council of the City of Moreno Valley, California, establishing a Homeless Ad Hoc Subcommittee pursuant to Legislative Policy 1.07 Council Subcommittee Meetings; and
2. Appoint two Councilmembers to serve on the Ad Hoc Subcommittee for the rest of the calendar year or until the Mayor makes the next annual Councilmember appointments to Subcommittees as ratified by majority vote of the Council.

SUMMARY

DISCUSSION

On March 19, 2024, Council approved and directed the Assistant City Manager (Administration) to work with the Mayor Cabrera and Mayor Pro Tem Barnard to develop the scope and characteristics of said Homeless Ad Hoc Subcommittee, which are detailed in the attached Resolution.

On August 20, 2024, Council approved to continue this item until a District 3 representative was elected and seated as a councilmember. In the approval it was referenced this item should return in January.
