TITLE SUMMARY: Authorization to Enter into a Purchase Agreement with

OneSource Supply Solutions for the Purchase of 15kV Medium Voltage Distribution Cable for Moreno Valley Utility

(MVU)

Recommendation(s)

That the City Council:

1. Authorize the City Manager to authorize the issuance of a purchase order to OneSource Supply Solutions in the amount of \$450,000 (\$397,862 plus contingency) for the purchase of 15kV Medium Voltage Distribution Cable used for Capital Improvement Project (CIP) 805 0080 Line Extension and general stock by Moreno Valley Utility, funded by MVU's operating and capital funds.

SUMMARY

This report recommends authorizing a purchase order in the amount of \$450,000 to OneSource Supply Solutions for the purchase of 15kV Medium Voltage Distribution Cable for the Capital Improvement Project (CIP) 805 0080, Line Extension. The purchase of this item will allow Moreno Valley Utility to extend its electrical service north of the State Route 60 freeway from Moreno Beach Drive. MVU capital funds will fund the cable purchase up to the authorized amount for fiscal years 2024-2025.

DISCUSSION

A Request for Quote (RFQ) was placed in OpenGov, the City's online bidding portal, from December 13, 2024, through December 27, 2024. All RFQ Questions and Answers were posted on OpenGov.

OneSource Supply Solutions was the second-lowest bidder for the project. The lowest bidder for the project was Hyundai, which could not be selected due to discrepancies in their submission. Specifically, Hyundai quoted for 1/C (single conductor) when the request was for 3/C (Triplex/Three conductors). In light of this, staff recommends proceeding with a purchase agreement with OneSource to purchase cable as needed for CIP 805 0080.

ALTERNATIVES

- Approve and authorize the recommended actions as presented in this staff report. Staff recommends this alternative because it will allow Moreno Valley Utility (MVU) to expand the service territory.
- 2. Do not approve and authorize the recommended actions as presented in this staff report. Staff does not recommend this alternative because it will not allow MVU to expand the service territory.

FISCAL IMPACT

This project is included in the Fiscal Year 2024/2025 capital budget. It will be financed by use of Moreno Valley Utility's restricted fund balance.
