TITLE SUMMARY:	Acceptance of the Federal Safe Streets and Roads for All Grant for Traffic Safety Improvements (Project No. 808 0041)

Recommendation(s)

1. Accept and approve the Safe Streets and Roads for All Grant Agreement between the Federal Highway Administration and the City of Moreno Valley in the amount of \$280,000.00 (Fund 2301) with the City local match of \$70,000.00 (Fund 3004), and

2. Authorize the Public Works Director/City Engineer to execute the attached Grant Agreement, subject to any minor changes initiated by United States Department of Transportation and the approval of the City Attorney; and

3. Authorize the Public Works Director/City Engineer to execute any subsequent amendments to the Agreement, subject to the approval of the City Attorney; and

4. Authorize a budget adjustment as set forth in the Fiscal Impact section of this report.

SUMMARY

This report recommends approval of the agreement with the Federal Highway Administration (FHWA) to accept the Safe Streets and Roads for All (SS4A) Grant funds in the amount of \$280,000 (80%) with a City local match requirement of \$70,000 (20%). The total project cost is \$350,000 to analyze and improve traffic safety at signalized intersections. The grant award, \$280,000, will be allocated to Fund 2301 (Capital Projects

Reimbursement). The City's 20 percent local match obligation, \$70,000 will be funded with Fund 3004 (Traffic Signal Mitigation). There is no impact to the General Fund.

DISCUSSION

The Bipartisan Infrastructure Law (BIL) established the new Safe Streets and Roads for All (SS4A) discretionary program with \$5 billion in appropriated funds over the next 5 years. The SS4A program funds regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries.

The SS4A program supports Secretary of Transportation Pete Buttigieg's National Roadway Safety Strategy and the Department's goal of zero deaths and serious injuries on our nation's roadways.

On May 17, 2024, the City of Moreno Valley (City) was awarded a grant in the amount of \$280,000, 80% of the total project cost, \$350,000. The City's 20% local match requirement is \$70,000 which is funded by Traffic Signal Mitigation Funds (Fund 3004).

The City has approximately 197 signalized intersections citywide. Staff would like to analyze these intersections to gather information that will help the City better understand the patterns, conditions, and behaviors present at our City intersections. This analysis will aid staff in identifying issues, forecasting future traffic flow, and assist with recommending effective countermeasures and solutions to enhance the safety, efficiency and flow of traffic throughout the City. The City has not previously had the opportunity to embark upon an intersection-specific study of this kind. Therefore acceptance of this grant positions the City with the opportunity to take an important step towards innovating and improving our City's intersections.

ALTERNATIVES

- 1. Approve and authorize the recommendations as presented in this report. *This alternative will enable the City to receive the* Safe Streets and Roads for All (SS4A) *Grant funds from U.S. Department of Transportation FHWA.*
- 2. Do not approve the recommended actions as presented in this staff report. *This alternative will prohibit the City from receiving the* Safe Streets and Roads for All (SS4A) *Grant funds from U.S. Department of Transportation FHWA*.

FISCAL IMPACT

The project is funded by the Safe Streets and Roads for All (SS4A) Grant Program. The total project cost will be \$350,000 wherein grant funding will be \$280,000 and City match will be \$70,000. The grant award, \$280,000, will be allocated to Fund 2301 (Capital Projects Reimbursement). The City's 20 percent local match obligation, \$70,000 will be funded with Fund 3004 (Traffic Signal Mitigation). There is no impact to the General Fund.
