TITLE SUMMARY: Confirmation Authorizing Certain Actions Related To The Implementations of Measure U

Recommendation(s)

That the City Council:

1. Confirm authorizing designated persons to examine transactions and use tax records related to Measure U and authorizing the City Manager to execute agreements with the California Department of Tax and Fee Administration for implementation of Measure U as described in Resolutions 2024-72-73.

SUMMARY

To ensure the timely implementation of Measure U, the California Department of Tax and Fee Administration (Department) was provided with copies of Resolutions 2024-72 and 2024-73 confirming authorization of designated persons to examine transactions and use tax records related to Measure U and authorization of the City Manager to execute agreements with the Department for implementation of Measure U as described in Resolutions 2024-72 and 2024-73.

DISCUSSION

On November 5, 2024, the voters approved Measure U (Ordinance No. 1015), amending the Moreno Valley Municipal Code and providing for a local transaction and use tax. Pursuant to Ordinance No. 1015 and Revenue and Taxation Code section 7270, the City (District) has entered into a contract with the California Department of Tax and Fee Administration (Department) to perform all functions incident to the administration and collection of local transaction and use taxes, which includes authorizing the City Manager to execute agreements with the Department for implementation of Measure U and authorizing designated officers, employees and representatives of the City (District) to examine confidential pertaining to transactions and use taxes collected by the Department for the City (District). The above authorizations were provided to the Department as set forth in Resolutions 2024-72 and 2024-73.

ALTERNATIVES

1. Do not confirm that the City Council authorized the actions as authorized under Ordinance 2015. (Staff does not recommend this action.)
2. Confirm the aforementioned authorizations as authorized under Ordinance 2015. (Staff recommends this action.)

FISCAL IMPACT

This will confirm that the Department will administer Measure U which is anticipated to generate \$30,000,000 in annual General Fund revenue which may be used to maintain 9-1-1 emergency response times, robbery/burglary prevention, neighborhood police patrols/fire engine service levels; address homelessness, traffic; repair potholes/streets; keep public areas safe/clean; help retain local businesses; maintain senior services, youth/afterschool programs, and other general services.
