| TITLE SUMMARY: | Adoption of the Proposed Resolution for the Quitclaim of Pedestrian and Vehicular Abutter's Restrictions to Allow for Eastern Municipal Water District Access to a Proposed Facility |

Recommendation(s)

That the City Council:

1. Adopt Resolution No. 2025-____. A Resolution of the City Council of the City Moreno Valley, California, Ordering the Quitclaim of City's Interest in Pedestrian and Vehicular Abutter's Rights along Alessandro Boulevard West of Larissa Street; and

2. Direct the City Clerk to certify said resolution and transmit a copy of the resolution to the County Recorder's office for recording.

SUMMARY

This report recommends adoption of the proposed resolution for the quitclaim of the City's interest in pedestrian and vehicular abutter's rights along approximately 80 feet of the south side of Alessandro Boulevard, west of Larissa Street, as shown on Exhibit B of the attached quitclaim deed. This quitclaim will grant access to a proposed Eastern Municipal Water District (EMWD) facility on Lot 1 and Lot 2 of Tract Map No. 38236.

DISCUSSION

The release and relinquishment of pedestrian and vehicular abutter's rights was accepted by the City under recorded Tract Map 38236, Map Book 493, pages 29-50, recorded on October 24, 2023. The quitclaim of this acceptance will restore the right to allow pedestrian and vehicular access along Alessandro Boulevard to developer D.R. Horton Los Angeles Holding Company, Inc (D.R. Horton). The rights to pedestrian and vehicular access will subsequently allow D.R. Horton to provide access to a recently approved driveway approach for an EMWD facility.

On December 12, 2024, the Planning Commission determined that the quitclaim is Categorically Exempt from the California Environmental Quality Act (CEQA) and CEQA Guidelines as a Commonsense Exemption, in accordance with the CEQA Guidelines Section 15061 (b)(3), and found that the quitclaim is in conformance with the General Plan, pursuant to sections 8300 et seq. of the Streets and Highways Code of the State of California and Government Code Section 65402.

ALTERNATIVES

- 1. Approve the recommended actions as presented in this staff report. Staff recommends this alternative as this will grant access to an EMWD facility.
- 2. Do not approve the recommended actions as presented in this staff report. Staff does not recommend this alternative as this will prevent driveway access to an *EMWD* facility.

FISCAL IMPACT

No fiscal impact.
