## Recommendation(s)

That the City Council and CSD:

1. Approve the naming of the new park located on the corner of Alessandro Boulevard and Oliver Street.

## <u>SUMMARY</u>

This report recommends approval of naming the new part located on the corner of Alessandro Boulevard and Oliver Street (Tract 38236). The 1.8-acre park site is in the Bella Sera development. Based on its location and in line with the City's Park Naming Policy, it is recommended that the new park be named Bella Sera Park.

#### **DISCUSSION**

The City's Park Naming Policy was created to facilitate the process of naming new parks constructed within our City. Some of the criteria for the selection of names includes

naming parks after a dedicated City street, avenue, or boulevard. If a park is located adjacent to a school site, the park may bear the same name as the school. Additionally, a park may be named after a housing tract that the project is located within.

The new 1.8-acre park site is in the Bella Sera development and based on the location, the park name "Bella Sera Park" is being recommended.

The neighborhood park will include amenities such as playground structures, large picnic shelter, back-to-back basketball courts, fitness stations, large turf area and a walking path.

The Parks, Community Services and Trails Committee made a recommendation at their regular meeting held on February 6, 2025, to name the new park site Bella Sera Park.

- 1. Approve the naming of the park site as recommended by this report.
- 2. Do not approve the name as recommended and provide an alternative name for the park.
