The Joint Task Force met on February 18th. In addition to City representatives, representatives from the Moreno Valley Unified School District, Val Verde Unified School District, California State Parks at Lake Perris, Riverside County Board of Supervisors - 5th District, Think Together and Rising Stars Business Academy attended the meeting. Highlights include:

- The City of Moreno Valley's and Moreno Valley Unified School
 District's 'Joint Use Agreement', that pertains to pool use for
 residents during the Summer Break. Of course, the biggest caveat
 is Public Safety and Insurance, however, it has been agreed that
 there will be ability for this upcoming School Year.
- Moreno Valley Unified School District and Val Verde Unified School
 District echoed their unity during a time of fear and uncertainty as it
 pertains to student attendance. Both <u>Dr. Ruvalcaba</u> from MVUSD
 and Deputy Superintendent <u>Mark LeNoir</u> from VVUSD are
 committed to all our students and their ability to receive an
 education.
- THINK Together, gave a brief update on their capacities. THINK
 Together has 400 Employees that cover over 5,000 after-school
 students. These students are spread throughout MVUSD and
 VVUSD, and the team is focusing on Policy and Procedures within
 both School District's specific jurisdiction to ensure students and
 parents are properly served.

- California State Park Lake Perris, are continuing their efforts on improvements in the area, specifically on the Southside of the Lake that border Perris and Ramona Express Way.
- Riverside County Supervisor's Office, 5th District, is promoting and accepting applications for its 'Furry Pets Adoption Program'. The program seeks to assist pets from the San Jacinto Animal, by granting screened individuals a chance to adopt a pet for a few weeks. All costs are subsidized by the program, with the option of long-term adoption available after the conclusion of an adoption period.
