L.1.1 March Joint Powers Commission (JPC)

L.1.2 Riverside County Habitat Conservation Agency Board of Directors (RCHCA)

L.1.3 Riverside County Transportation Commission (RCTC)

Mayor Cabrera reported the following:

At the RCTC Budget and Implementation Committee meeting held on March 24th.

The Committee heard a presentation on the vanpool program, which offers Riverside County commuters a convenient and cost-effective alternative to driving alone. The agreements were awarded to Enterprise Rent-a-Car and Green Commuter.

Additionally, the Committee received updates on State and Federal legislation.

L.1.4 Riverside Transit Agency Board of Directors (RTA)

Councilmember Barnard reported the following:

At the March 27, 2025, RTA Board of Directors meeting heard a presentation on the procurement process for liability insurance and risk management services. They awarded a \$835,842 contract to Alliant Insurance Services, Inc.

L.1.5 Western Riverside Council of Governments Executive Committee (WRCOG)

Mayor Pro Tem Baca-Santa Cruz reported the following:

At the WRCOG Executive Committee meeting on March 3, 2025, reports for Fiscal Department activities, committees and agency activities, and various (external) committees were received and filed.

Additionally, the Executive Committee discussed the following key items:

Western Riverside County Clean Cities Coalition Activities Update

- The Coalition kicked off its Municipal Green Zones project on February 5, 2025. The project is funded through a joint CARB and California Energy Commission grant to support zero-emission vehicle deployment in the subregion.
- The Coalition continues its work with electric vehicle car share operator EVGIDE to deploy vehicles in the subregion. The project is supported by a \$1.8M grant from the CARB Clean Mobility Options Program.
- The Coalition continues to facilitate the Inland Zero Emission Vehicle (ZEV) Network, designed to support members in understanding zero-emission vehicle technology, navigating policy, and creating beneficial partnerships around vehicle and infrastructure deployment. The Network meets regularly and is open to all Clean Cities members.
- The Coalition will host the Inland ZEV Forum in late summer 2025 and will host forums, workshops, an expo, and other partnership-building opportunities to support ZEV deployment.
- As a result of the White House's new Administration's executive orders and federal memos, WRCOG has received stop-work orders for the Houston to Los Angeles (H2LA) Heavy-Duty Hydrogen Corridor Planning project and the Clean Cities Energy and Environmental Justice Initiative (CCEEJI). The CCEEJI program has been closed out, and the H2LA program is on hold pending further direction from the U.S. Department of Energy.
- CARB has withdrawn a waiver from the U.S. EPA for the Advanced Clean Fleets ruling on drayage, priority fleets, and federal fleets. The agency cannot enforce the ruling on these fleets but maintains the authority to enforce the ruling on state and local government fleets.

Environmental Department Program Activities Update

 For solid waste programs, staff have continued to provide quarterly meetings, reports, and guest expert speakers to the Solid Waste Committee.

- In 2024, the Love Your Neighborhood Program participated in 22 community events, engaged over 1,300 volunteers and removed 13 tons of trash from neighborhoods, parks, and public spaces.
- The Eco Hero Program provided 40 presentations to over 5,200 elementary school students within WRCOG member jurisdictions.
- In 2024, the Food Rescue Program facilitated the rescue of over 91K pounds of edible food, thereby reducing 133.27 metric tons of CO2e.

Consideration of Opposition to SCAQMD Proposed Amended Rules 1111 and 1121

- AQMD's Proposed Amended Rules (PRA) 1111 and 1121 seek to reduce nitrogen oxide (NOx) emissions by transitioning residential furnaces and water heaters to zeroemission alternatives, impacting local governments, homeowners, and businesses.
- While the rules aim to improve air quality, stakeholders have raised concerns about affordability, technological readiness, and the feasibility of implementation.
- The PRAs support the 2022 AQMP's target reducing Nox emissions by 67% by the year 2037, facilitating compliance with federal air quality standards.
- AQMD has developed the "Go Zero" rebate program, allocating \$21M to assist residents and small businesses transition to zero-emission appliances, thereby offsetting some of the associated costs.
- Challenges and concerns outweigh the benefits of PRAs 1111 and 1121:
- A financial burden of replacing existing appliances with zeroemission units could disproportionately affect low-income households and small businesses.
- Industry experts have highlighted potential challenges regarding the availability and maturity of zero-emission appliances suitable for retrofitting older buildings.

- There are concerns about whether current technologies can meet the diverse needs of consumers without causing project delays and increased costs.
- The proposed timeline for compliance has been criticized as aggressive, potentially leading to supply chain issues and inflated prices.
- Several local governments and councils of governments have formally opposed the proposed amendments, highlighting concerns about high implementation costs and minimal air quality benefits.
