Recommendation(s)

That the City Council:

- 1. Award an Agreement to Professional Consultant Services to HR Green Pacific, Inc. to provide engineering design service for ADA Curb Ramp Remediation Project Number 801 0109; and
- 2. Authorize the City Manager to execute an Agreement for Professional Consultant Services with HR Green Pacific, Inc. in the amount of \$169,490 and subject to the approval of the City Attorney; and
- 3. Authorize the issuance of a Purchase Order for HR Green Pacific, Inc. in the amount of \$169,490 when the Agreement has been signed by all parties; and

4. Authorize the City Manager to execute any subsequent Amendments to the Agreement with HR Green Pacific, Inc. subject to the approval of the City Attorney.

SUMMARY

The following report recommends awarding an agreement for professional consultant services to HR Green Pacific, Inc. to provide design engineering services for the Americans with Disabilities Act (ADA) Curb Ramp Remediation Project in the amount of \$169,490. The project is fully funded by the California Department of Transportation (Caltrans), Cycle 6 Active Transportation Program Grant in Fund 2301 (Capital Projects Grants). There is no impact to the General Fund.

DISCUSSION

The Active Transportation Program (ATP) was established by Senate Bill 99 to fund programs and initiatives that promote the use of active transportation methods such as walking and biking. This program consolidates various transportation programs, drawing from both state and federal funds. Key goals of the ATP include enhancing the safety and mobility of non-motorized users and supporting regional agencies in reducing greenhouse gas emissions. These programs and initiatives aim to improve public health and benefit all types of users, particularly those in disadvantaged communities.

The City submitted ATP an application for the ADA Curb Ramps Remediation Project. All curb ramp locations were originally included in the Citywide Pavement Rehabilitation Program. This award will subside with the City's paving projects and free up \$1,523,000 in funding. The projects will build 66 pedestrian curb ramps.

The City posted a Request for Proposal (RFP) for professional engineering services on January 22,2025 and received a total of six (6) responses by the deadline of February 28, 2025. The evaluation by the engineers in Public Works recommended HR Green Pacific, Inc. be awarded.

ALTERNATIVES

- 1. Approve and authorize the recommendations as presented in this report. This alternative will allow the projects to move forward in a timely manner and enable the city to receive reimbursement from Caltrans. Staff recommends this alternative.
- 2. Do not approve the recommended actions as presented in this staff report. This alternative will increase the cost of the City's paving project by \$1,523,000. Staff does not recommend this alternative.

FISCAL IMPACT

The ADA Curb Ramps Remediation Project (801 0109) is fully funded by the Caltrans Cycle 6 ATP Grant awarded in December 2023. Funds are allocated to Capital Projects Grants, Fund 2301. There is no impact to the General Fund.
