The Emerging Leaders Council was established as a standing committee with two-year terms by Resolution 2014-30. The attached Resolution 2021-31 modifies existing provisions governing the Emerging Leaders Council.

To apply to be an ELC Commissioner applicants must:

- Be between 14 and 20 years old;
- Be enrolled in an educational institution;
- Serve a minimum two-year term;
- Attend monthly meetings;
- Recruit two youth members before the end of their term;

Individuals who wish to join the ELC may join at any time by submitting an application. Incomplete applications will be returned. APPLICATIONS MUST BE TYPED - HAND WRITTEN APPLICATIONS WILL NOT BE ACCEPTED.
