

RESOLUTION NO. 2025-XX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, ADOPTING THE RATE ADJUSTMENT FOR THE SOLID WASTE AND RECYCLING SERVICE PROVIDED BY USA WASTE OF CALIFORNIA, INC., A DELAWARE CORPORATION, DBA WASTE MANAGEMENT OF THE INLAND EMPIRE FOR FY 2025-26.

WHEREAS, the City of Moreno Valley ("City") City Council has in the past approved and adopted the annual rate adjustment for the solid waste and recycling service provided by USA Waste of California, Inc., a Delaware corporation, dba Waste Management of the Inland Empire: and

WHEREAS, the adjustment is also needed to assist with cost increases associated with the cost-of-living adjustments from December 2023 to December 2024; and

WHEREAS, the City Council declares its intention of maintaining reasonable rates for the collection, transportation, recycling, composting, and disposal of Solid Waste and construction debris and for providing temporary bin/roll-off services to commercial and residential premises within the boundaries of the city of Moreno Valley; and

WHEREAS, data supporting the estimated rate adjustment has been made available to the City Council and to the public; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

1. The attached FY 2025-26 rate sheet replaces the First Amendment to Third Amendment, as Exhibit "C", of the franchise agreement with USA Waste of California, Inc., a Delaware corporation, dba Waste Management of the Inland Empire.

2. The fees approved, increased, and established herein shall become effective July 1, 2025. Other fees include commercial organics, recycling bins, residential cart counts, and roll-off calculations. The primary fees are referenced below.
