A RESOLUTION OF THE CITY COUNCIL OF MORENO VALLEY, CALIFORNIA, ADOPTING A MOTTO FOR THE ENVIRONMENTAL AND HISTORICAL PRESERVATION COMMISSION

WHEREAS, Section 2.21.030 (Powers and Duties) of the Moreno Valley Municipal Code provides in part that the Environmental and Historical Preservation Commission ("Commission") has the general power and duty to act in an advisory capacity to the City Council on "matters related to preservation of local cultural and/or historical significance"; and

WHEREAS, A motto is a short phrase or sentence expressing a guiding principle or ideal, often used by organizations and groups to represent their beliefs and values. The City itself has the motto of "People, Pride, and Progress"; and

WHEREAS, At the March 10, 2025, EHPC meeting, the Commissioners discussed multiple options for a motto. The EHPC believes its proposed motto, "Protect, Defend, and Promote Our Heritage through Preservation," captures the working goals of the Commission; and

WHEREAS, At the May 12, 2025, EHPC meeting, the Commissioners voted unanimously to recommend to City Council the adoption of an EHPC official motto, "Protect, Defend, and Promote Our Heritage through Preservation"; and

WHEREAS, At the August 19, 2025, City Council Meeting, the City Council voted unanimously to direct staff to bring back a Resolution for the adoption of the EHPC's proposed official motto, "Protect, Defend, and Promote Our Heritage through Preservation."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. Recitals

That the recitals set forth above are true and correct.

Section 2. Severability

That the City Council declares that, should any provision, section, paragraph, sentence or word of this Resolution be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of this Resolution as hereby adopted shall remain in full force and effect.
