A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, AMENDING POLICY 1.01 RULES OF PROCEDURE FOR CITY COUNCIL MEETINGS

WHEREAS, Section 2.04.040 of the City of Moreno Valley Municipal Code requires that the City Council adopt Rules of Procedure to govern the procedures and conduct of its meetings; and

WHEREAS, the City Council has previously adopted, repealed, re-adopted and amended the City of Moreno Valley City Council Policy 1.01 Rules of Procedure for City Council Meetings and Related Functions and Activities; and

WHEREAS, the Brown Act in Government Code Section 54954.2 provides for a minimum 72-hour posting period for regular meeting agendas; and

WHEREAS, City Council has determined that it is in the best interests of the City of Moreno Valley that the City Council further amend Policy 1.01 Rules of Procedure for City Council Meetings and Related Functions and Activities to amend the agenda order of business, adding the following land acknowledgement:

**We wish to acknowledge that we are on the unceded lands of the Cahuilla and Páyomkawichum or Luiseño, who as original inhabitants, and now as Sovereign Tribal Nations, have continued to live and thrive upon these lands since time immemorial.**

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MORENO VALLEY, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

1. Section 1.1.2.1 of The Rules of Procedure for City Council Meetings and Related Functions and Activities is revised as shown in the following:
